

# WHERE DO I GO?? CLERK'S OFFICE DIRECTORY and REGISTER OF DEEDS

#### Bookkeeping 1st Floor Rm #1101

- · Check balances on Supervised Probation
- Checks (such as the return of Cash Bonds)
- Mail / Deliveries (USPS, FedEx etc.)

#### Child Support -1st Floor Rm #1101

- Child Support-Dept. of Social Services (DSS) ONLY
- NOTE: Child Support <u>CANNOT</u> look up court dates. Defendants must call DSS case manager.
- Purge payments for Child Support

### Cashier-1st Floor Rm #1200

- Pay for Certified Background Checks
- Pay Court Costs on Court Cases
- Pay Supervised Probation
- Pay for Marriages

#### District Criminal & Traffic Records-1st Floor Rm #1300

- Criminal & Traffic court dates/courtrooms
- Pay Traffic Citations
- Limited Driving Privilege (LDP) due to DWI or Speeding in State
- Bond Forfeitures
- Vehicle Seizures

#### Civil Judgments-1st Floor Rm #1400

- Divorce Decree (More than 10 years)
- Appeals-Small Claims/Evictions (Rent Bonds)
- Collection on Judgments (Notice of Rights, Writ of Execution, Payments)
- Miscellaneous Liens (Tax, HOA, Labor & Materialmen)
- Name Change-Resumption of Name

#### Civil Filings-1st Floor-Rm #1500

- Lawsuit Filings
- · Eviction (rental property) Filings
- Restraining Orders (DVPO's, DPO's)
- · Notice of Contract
- Motor Vehicle Liens- ALL liens but LT-264A
- Limited Driving Privilege (LDP) due to DWLR or Speeding Out of State
- Foreclosures/Auctions (Taxes)
- Divorce Decree (Less than 10 years)

• Gun Permits

#### Superior Criminal Records-2nd Floor Rm #2100
